### **INTRASOFT International in a €5.8 million program in Finland**

**Luxembourg, July 22, 2010** — INTRASOFT International, a member of INTRACOM IT Services Group — has been selected by the European Chemicals Agency (ECHA), based in Helsinki, Finland, as one of the preferred suppliers for 4 lots out of 10 under a 2-year competitive framework contract for the provision of IT consulting services with a maximum capacity budget of EUR 5.8 million for all preferred suppliers. The initial estimate is that INTRASOFT International may receive one fourth of the total budget for the contract. The contract may also be extended for 2 additional periods of 12 months. This project will boost INTRASOFT International's profile in Helsinki, Finland, a new area of expansion for the company's business operations.

ECHA manages all registration, authorization, evaluation and restriction processes for chemical substances across the EU in order to ensure high standards of safety and consistency, and to safeguard the competitiveness of the European chemicals industry. It also provides scientific and technical advice to EU Member States as well as educational and research institutes.

The first specific contract agreement between INTRASOFT International and ECHA has been signed. The contract budget is divided into four lots: For Lot 1, INTRASOFT International will provide Microsoft Windows System administration services; Lot 2 will involve the provision of Unix System administration services; Lot 3 the provision of data administration services; and Lot 7 the provision of software development services.

Mr Athanassios Kotsis, CEO of INTRASOFT International, stated: "INTRASOFT International is delighted to be working with a prestigious new client within Europe. The company is expanding its geographical reach with its new contract for the European Chemicals Agency, our first client in Finland, and we hope this will be the beginning of an extremely rewarding working partnership."
